1704Giles, who was under age, had William Sewell appointed his guardian

6 Apr 1705Obediah Smith and Mary his wife, of Henrico Co., to Lanslott Woodward and Elizabeth his wife, of James City Co., said Lanslott and Obediah are siezed in right of their wives, which descended to said Mary and Elizabeth from their father, William Cocke. They also have another plantation in James City Co., which also descended to said Mary and Elizabeth from John Flowers, their uncle on their mother's side. Obediah and Mary Smith are to have the plantation in Henrico Co., on Turkey Island Creek, and joining John Pleasants mill and lines of Richard Povay, John Cocke's and Giles Carter, now in possession of John Ast and Henry Lester, 254 acres. Lanslott and Elizabeth Woodward to have the plantation in James City Co. On Chickahominy river and Warring Creek, next to Bennett Freeman and William Wigg, now in occupation of Thomas Hicks.

Tobacco, 50 acres which Giles Carter, dec?d, father of said Giles, purchas ed of William Cocke 1 apr 1685 and was deeded by said Giles, dec?d to his son, 1 Aug 1686. (or 1 Apr 1686) Witnesses: Samuel Hozey, Matthew Taylor Signed: Giles Carter Recorded: 1 st Mon in Oct 1711 Mary, wife of Carter, relinquished her dower right. (Henrico Co., VA, Deed # 34 pg 101)

10 Oct 1711Giles Carter purchased from John Pleasants for 5000 Lbs. tobo.(tobacco) 94 acres on S. side Chickahominey Swamp, Henrico County and Parish, Virginia. 6 Note: Giles bought back the land he'd sold in January. Then, six years later he sold the same land to his son-in-law.

1 Mar 1717Giles sold the 94 acres for 20 pounds to Ralph HUDSPETH of Charles City County and Westover Parish. Witnesses: James Powell Cocke and Edward Moseby. (Henrico Co. Deeds and Wills, 1714-1718, p. 234) 15 Note: Ralph HUDSPETH sold that land in 1722 to William Willis.

17 Aug 1725Giles Carter patented 48 Acres in Henrico Co., VA; on N. side of James River, on E. side of Deep Run, adjoining John & James Cocke & William Sewell. 5 shillings. The same day Robert Carter patented 327 acres in Henrico Co. on the S. side of the James River. Note: Probably not his son. Giles' son Robert was about 7 years old.

1725William Sewell died; Giles was sole heir and executor. (Henrico Co Wills and Deeds 1725-37, p 2) p 297 3

16 Sep 1728Giles & Mary were legatees of her father's will. Robert POVALL bequeathed 10 barrels of corn to Giles and a negro to Mary.
