2. **Richard Cocke**, the elder, Gent., of *Bremo*, b. 10 Dec 1739; d. 20 Nov 1706, age 66; said to have m. **Elizabeth** _____; he inherited the 650 ac. home plantation of *Bremo* from the 1663 will of his father; in 1678 Mr. Richard Cocke of *Turkey Island* was charged with 5 taxables in Henrico Co.; he was appointed High Sheriff of Henrico 30 Apr 1691 & 9 Apr 1693 (HCVD-1 p. 71, 78); children from his will:

21-2 **Bowler Cocke**, Col., b. aft 1685; of *Bremo* (HCVW-2 p. 158); d. 22 Aug 1769 at his seat at *Shirley* (*Virginia Gazette*); said to have m/1 **Sarah Fleming**; d/o Charles Fleming of New Kent Co.; m/2 **Elizabeth Hill** of Charles City Co.; said to have been d/o Edward Hill of *Shirley* and widow of John Carter of Lancaster Co.; Bowler was a Justice and Clerk of Henrico Co., a Vestryman of Henrico Parish and a member of the House of Burgess; 1 May 1728 he was appointed Clerk of Henrico Co. 4 Apr 1720; from Aaron Leister of Henrico Co. to Bowler Cocke of Essex Co.; 2 negroes, and 91 ac. west of William Cocke on *Curles Swamp*; wit. by John and Richard Cocke, Jr. among others (HCVD-2 p. 80)

16 Jun 1727; Bowler Cocke granted 800 ac. Henrico Co. on s. side of James River on east side of George Stovalls *Horse-pen-branch* (LOP 13.77)

13 Oct 1727; Bowler Cocke granted 400 ac. Henrico Co. on s. side of James River on *Muddy Creek* (LOP 13.194)

26 Jun 1731; Bowler Cocke granted 2,400 ac. Goochland Co. on s. side of James River on *Muddy Creek* (LOP 14.187)

9 Sep 1733; from Bowler Cocke, Gent., to Benjamin Hobson, both of Henrico Co.; for £30; 570 ac. bounded by *White Oak Swamp* granted James Cocke 28 Oct 1702; deserted and then granted to Richard Cocke 1 May 1706 and given by him to his son Bowler (HCVD-2 p. 149)

Sep Ct. 1739; Bowler & James Cocke took oath as officers of the militia for Henrico Co. (HCVD-3 p. 83)

5 Jul 1748; 1st Mon Jul 1748; from Bowler Cocke the elder to Bowler Cocke the younger; for 5s; 90 ac. in Henrico Parish bounded by *Curles Swamp* and by *Bremo*, etc. (HCVD-3 p. 56)

To son Richard, 400 ac. on *Butterwood Creek*, negroes, etc.

To son William, the other 400 ac. on *Butterwood Creek*, other land, negroes, etc.
